RESOLUTION NO. 88-9

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA HEIGHTS, CALIFORNIA, CONSENTING TO ESTABLISHMENT OF FULLERTON ROAD WITHIN THE CITY AS A PART OF THE SYSTEM OF HIGHWAYS OF THE COUNTY OF LOS ANGELES

WHEREAS, by reason of its location and travel thereon, Fullerton Road from the northeast City boundary to the Orange County line, within the City of La Habra Heights, County of Los Angeles, State of California, is an integral part of the highway system serving this area of the County; and

WHEREAS, Fullerton Road is one of only two routes over the Puente Hills that provides motorists direct access between the mid-San Gabriel Valley and Orange County; and

WHEREAS, Fullerton Road, as it now exists, is a heavily traveled circuitous two-lane roadway which is congested during peak traffic periods; and

WHEREAS, the portion northerly of the City boundary is scheduled for realignment and full improvement through the unincorporated County area; and

WHEREAS, the portion of Fullerton Road to the south in Orange County is now a four-lane facility; and

WHEREAS, the Board of Supervisors, on August 12, 1986, duly adopted a Resolution declaring the portion of Fullerton Road from the northeast City boundary to the Orange County line and intersecting streets appurtenant to the construction thereof, within the City of La Habra Heights, to be a part of the System of Highways of the County of Los Angeles, all as provided in Sections 1700 to 1704 inclusive of the Streets and Highways Code of the State of California; and

WHEREAS, the Board of Supervisors by that Resolution requested the City Council of the City of La Habra Heights to give its consent to allow the County to acquire right of way, construct improvements and perform appurtenant work on said portion of Fullerton Road in the City of La Habra Heights described above; and

WHEREAS, on September 23, 1986, this City Council, in Resolution No. 86-30, consented to the establishment of Fullerton Road within the City of La Habra Heights as a County Highway for these purposes as provided by Sections 1700 to 1704 inclusive of the Streets and Highways Code; and

WHEREAS, the Board of Supervisors, by a Resolution adopted on May 10, 1988, also agreed to maintain Fullerton Road from the northeast City boundary (on the proposed new alignment northerly of Kashlan Road and generally along the existing alignment southerly of Kashlan Road) to the Orange County line within the City of La Habra Heights.

NOW, THEREFORE, the City Council of the City of La Habra Heights, California, does hereby resolve as follows:


Consent to Inclusion in County Highway System. This City Council does hereby consent to the establishment of Fullerton Road from the northeast City boundary (on the proposed new alignment northerly of Kashlan Road and generally along the existing alignment southerly of Kashlan Road) to the Orange County line, within the City of La Habra Heights, to be a part of the System of Highways of the County of Los Angeles as provided in Sections 1700 to 1704 inclusive of the Streets and Highways Code of the State of California. Said consent is for the additional purpose of maintaining this street and performing appurtenant work as may be necessary by the County of Los Angeles.
